Prayer Stones


During the next few weeks, please consider the scripture – Matthew 3:3 in which John the Baptist tells people to get ready for Christ – to pave the way.


- Pray for the congregations who came before us – who generously and faithfully paved the way for us to follow.

Two Campaigns: Questions & Answers

The Pave the Way Capital Campaign and the Giving With Gratitude Annual Stewardship Campaign have two different purposes, and both are critically important to our church. When the church Vestry and Finance Committee plans for the future, they estimate what next year's day-to-day expenses will be. This becomes the church's operating budget. Periodically, the Vestry identifies the need for a capital campaign to fund long-term asset expenditures, so a capital budget is created. Please prayerfully consider our church's needs and contribute to both campaigns. Your support is needed.

Capital Campaign and the annual stewardship campaign, Giving With Gratitude? The Pave the Way Campaign covers the cost of capital improvements and expenses such as expanding the sacristy, adding parking, deferred maintenance, organ repairs, enhancements to the sanctuary, repairs to Holzhalb Hall, deferred maintenance for the Chapel, the HVAC system, and more. These are items that our annual operating budget does not cover. The annual stewardship campaign – Giving With Gratitude – covers the church's recurring expenses such as salaries and benefits, administrative costs, insurance, office supplies, utilities, payroll expenses, routine maintenance, security, Diocese commitments, and other recurring costs.

Yes, please! Think of the annual stewardship campaigns?
Yes, please! Think of the annual stewardship campaign –
Giving With Gratitude – as you would your own household
budget – bills that must be paid on a monthly, quarterly, or
annual basis. Think of the capital campaign – Pave the Way –
as a way to raise funds to pay for enhancements and major
improvements as well as major repairs and replacements.
These are one-time costs, as opposed to recurring costs.
Think of the Pave the Way Capital Campaign expenses
like you would if you were adding onto your existing home,
replacing a roof or remodeling your kitchen. These are
one-time investments into your property – not something
you'd do every year.

What are the giving timeframes for both campaigns? Please provide financial gifts for the annual Giving With Gratitude during the calendar year 2026 – either as one time gift, quarterly, monthly, or weekly. For the Pave the Way Capital Campaign, this is a three-year timeframe 2026 to 2028. So, divide your commitment however works best for your family each year, but please complete your commitment before December 31st, 2028. However, the sooner the church receives funds, the sooner projects can begin and complete.

What is a commitment card and what is its purpose? A commitment card is not a contract, but rather, it is a statement of your intent. The church's finance team needs to have knowledge of what the total dollar amounts are projected to be, and what schedule you plan on giving, so they can plan for upcoming expenditures with confidence.

- **5.** Are commitment amounts kept confidential? Yes! Only our church's financial office will have any knowledge of your confidential gift amount.
- 6. Can givers change the amount they want to give after making a commitment? Yes! If a family has a change in their financial circumstances after making the commitment, they can increase or decrease the amount by calling the church treasurer.
- When does the congregation receive the commitment cards? The week before Thanksgiving, the Pave the Way Communications team will mail out the commitment cards to each family. There are two cards in the packet:

 1) Capital campaign Pave the Way and 2) Annual stewardship campaign Giving With Gratitude.
- When do we turn in the commitment cards? On December 7th, Celebration & Commitment Sunday, please place your completed cards in the commitment envelope provided and bring to church (only one service that day 10 am), and place in the collection plate. Father Seth will then bless all the cards that day.
- Where will the Luncheon on Commitment Sunday take place? The Pave the Way Social Committee has a fantastic catered lunch planned in Holzhalb Hall immediately following the 10 am service. They will bring in additional tables and chairs to accommodate everyone. The Bishop will join us, as well. Make plans to attend.



Consider a Qualified Charitable Distribution (QCD)

What is a QCD?

- A Qualified Charitable Distribution (QCD) is a direct transfer from your IRA to a qualified 501(c)(3) nonprofit, such as Christ Episcopal Church.
- Available to IRA owners age 70½ or older.
- Annual limit: \$100,000 per person (\$200,000 for a married couple if both qualify).

Tax Benefits of a QCD

- Normally, traditional IRA withdrawals are taxed as ordinary income. A QCD is excluded from taxable income and is not included in adjusted gross income (AGI).
- If you are age 73 or older and required to take a Required Minimum Distribution (RMD), a QCD may satisfy all or part of your RMD without increasing taxable income.
- Lower AGI can reduce:
 - Federal income tax on Social Security benefits
 - Medicare premiums (Income-Related Monthly Adjustment Amount, or IRMAA)

- Provides tax benefits even if you take the standard deduction.
- Unlike traditional charitable deductions, QCDs reduce taxable income directly.

How to Make a QCD Gift

- Contact your IRA custodian and request a Qualified Charitable Distribution payable to: Christ Episcopal Church Covington (EIN: 72-0633945).
- 2. Ask your custodian to mail the check directly to:

- **3.** Notify the parish office at 985.892.3177 so your gift is recorded properly.
